Letter from the President The 2017 Annual Lacamas Shores Homeowners' Meeting

Dear Lacamas Shores Homeowner,

This year's Annual Homeowner's Meeting will be held <u>Saturday</u>, <u>March</u> 18, 2017 at the <u>Camas Meadow Golf</u> <u>Club at 1:00pm</u>. We highly encourage all Homeowners to attend this very



important meeting of the Association. The board will present to the membership the annual review of the last 12 months. We will also present the <u>2017 & 2018 Operating Budgets</u> for ratification by the membership. Finally, we will provide the membership the Board's goals for 2017 and 2018. If you want an update on "The State of the HOA" we highly encourage you to attend. There will be cookies and water provided.

Also noteworthy on the agenda will be the approval of the 2016 Annual Meeting minutes and the proposal to waive hiring a professionally certified auditor for our annual audit. The cost of a professional audit is approximately \$4000. The last independent audit was completed by the Fox & Company CPA firm for the year ending 2014, and an internal audit was completed for 2015. We will also hold an election for three expiring positions for the Board of Directors. If you are interested in running and would like your bio posted on our website, please email the Board. All candidates who are interested in running will need to be nominated from the floor and accept the nomination in person or by proxy at the annual meeting. Each candidate will also have the opportunity to address the membership at the meeting prior to the vote being taken.
